The railroad never accepted the new name and continued to use Kanorado, which made things a bit confusing for the post office. Finally, in 1903 permission was granted to change the name of the office to Kanorado.

Since its first postmaster, the Kanorado office has seen 17 postmasters. Sheldon, the current postmistress, has held the position since 1982 and has worked at the office for 19 years.

Other current employees include the office clerk, Eileen Wahl; the rural carrier, William Paul Taylor; and the sub-carrier, Jay Pettibone.

For the occasion of its 100th birthday, Goodland resident Marion C. Parker designed an envelope depicting the outside of the current office.
