## Fixing contract good move by city

City commissioners decided Monday not to approve the animal pound contract without more changes.

Four of the commissioners sat silently when a motion was made to approve the contract as presented, and the motion died for lack of a second.

The four commissioners had each said they did not like the contract because it called for the city to pay the utilities for the proposed animal pound built last year at the Paw Wash on the east edge of the city.

Commissioner Dave Daniels said he would not support the contract with the city paying the utilities, and felt in many ways the whole process over the past year had been badly handled.

His point was the city should not be paying the utilities for any private business because the city does not pay any other businesses utilities.

Commissioner Rick Billinger said he agreed, and felt the other clause about the county abating the property taxes was not good either.

Commissioner John Garcia and Mayor Josh Dechant made similar comments against the city paying the utilities.

Commissioner Annette Fairbanks, who has been working on the committee to develop the contract, said she understood and agreed the whole process was not handled properly. She said the idea of having the city pay the utilities and the county abate the property taxes was to keep the cost down.

City Manager Doug Gerber, who is a member of the committee, asked the commissioners if the contract could be approved if the utilities were pulled out.

Most of the commissioners agreed taking the clause out would make it more acceptable, and agreed to review the contract at the next commission meeting.

We felt the city commissioners were correct not to approve the contract as it was written, and feel the county commissioners should take similar action to take the plan to abate property taxes out of the contract.

A year ago Police Chief Ray Smee asked the city commission to have an agreement drawn up spelling out what the responsibility and cost should be for the dogs brought into the existing dog pound by Sherman County. For years there has not been any written agreement, and the city and animal shelter volunteers have been caring for all the dogs.

In February a donor stepped up and gave money to build a new animal pound east of town before any discussion or agreements had been drafted. After months of waiting for a draft agreement a select committee went behind closed doors to draft a contract between the city and county and Paw Wash owner on operating the animal pound.

The county finally agreed to help pay 30 percent of the cost with the city paying the larger share at 70 percent.

For the sake of the animals the new pound will be an improvement, and we know Kathy Schermerhorn will take good care of the animals.

The contract will be cleaner with the two clauses taken out even if that raises the annual contract cost.

Neither the city or county are wedded to staying with the contract after the first 18 months.

This process has taken a lot of twists and turns over the past year, and we feel the action last week was a good move by the city. When the contract comes back we hope it is approved by both the city and county to get this issue solved and move forward onto other things. — Tom Betz
