# Food program undergoing changes this month

The Prairie Land Food Program is undergoing some changes in the month of March. The pick up site had been moved from the Goodland Elks Lodge to the Knights of Columbus Hall, 7th and Caldwell. The move was brought on by a change in the time the driver of the truck would arrive. That time has been changed from 9:30 a.m. to 1:30 p.m.

"Prairie Land Food program is for everyone," said Director Linda Hagan. "There are no income requirements. A donation of

two hours of volunteer work is suggested for each prairie pack bought and the cost for a pack is \$23."

The packs usually contain around five meat items and 10 to 15 vegetable and fruit items.

March's Prairie Pak will contain a 1.6 pound tray pack of chicken drum, 30 ounces of white turkey breast tenderloins, a pound of lean ground beef, 20 ounces of center cut pork chops, a pound of boneless skinless chicken breast filets, potatoes, cauliflower,

apples, oranges and frozen blueberries.

The meat only package for \$14 is the meat items from the Prairie Pak and costs \$14 and one hour of service. The fruit and veggie pack for \$12 and one hour of service is the non meat items from the Prairie Pak.

There are also specials. The first special is the "Hen House Special" for \$21 and an hour of service of a 10 pound box of boneless homestyle breaded chicken breast tenders. The second special for \$16 and one hour of service is three 18-ounce bags of Black

Angus ground beef and cheese patties. The third special is a nine pound spiral slice ham for \$24 and one hour of service. The fourth special is a five pound prime ribeye roast for \$22 and one hour of service.

All packages can be purchased separately.

The program is a 501(c)(3) organization with a goal of providing nutritious food at a low cost to help stretch food dollars for everyone. It is funded through participation, the more people who participate, the greater

the purchasing power.

The volunteer work benefits the communities in as many ways as there are people.

Orders for March must be placed by Monday and pickup is on Saturday, March 27. ## Session planned to explain water rights database

The Northwest Groundwater Management District is offering a free seminar on the use of the on-line Water Information Management and Analysis System to be held at 1 p.m. on Wednesday, March 31 at the district office, 1175 S. Range, Colby.

"We often get calls from folks asking about web data and/or information on water, water rights, water levels, etc.," said Wayne Bossert, district manager. "We thought perhaps a series of group sessions might be helpful."

The first session will be on navigation and use of the Water Information Management and Analysis System maintained by the Division of Water Resources, but housed on the Kansas Geological Survey computers. He said the database contains all the public information relative to all Kansas water rights.

In the first session people will learn how to find it and use the site.

Bossert asks that anyone interested register so they can determine if a bigger room is needed. Call (785) 462-3915 or email [rwade@gmd4.org](mailto:rwade@gmd4.org) if you plan to attend.

Later sessions (if the response supports them) will be on water level data; well completion records; the High Plains Atlas; and perhaps other water-related sites if suggestions are offered from the participants.

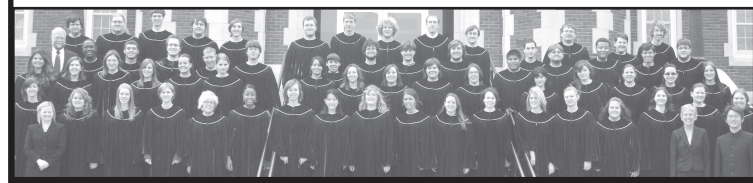
