## Goodland sends 16 to state championships

Max Jones Fieldhouse was truly maxed out Saturday as more than 500 young wrestlers, plus parents and friends filled the building for the District 4 Kansas Kids Tournament to qualify wrestlers for the Kansas Kids Championships in Topeka this weekend.

Hotels, motels, restaurants and other businesses around town reported increased customers on Friday and Saturday with the influx of the wrestlers and their families coming from 35 towns around western Kansas.

The Goodland Wrestling Club had 34 qualified for the district tournament and of those 16 finished in the top four positions to go on to Topeka.

Goodland wrestlers Lorenzo Delgado placed first in the high school division; Tate Withington, Evan Peter, Luis Ledesma, Ian Bonsall and John Peden finished second; Tayton Weeter, Tanner Gastineau, Aaron Avelar, Marvin Hernandez and Seth Miller finished third; and D.J. Knox, Dawson Holub, Coy Johnson, Rickey Milke, Brook Bahe and Drew House finished fourth.

The wrestling was pushed back half an hour Saturday morning because of a snow storm that came through the area on Friday. Another delay Saturday morning was caused by overloading the wireless network the organizers were counting on to record all the results. While everyone was asked to turn off computers and mobile devices in the fieldhouse, organizers handed out printed folders to allow each of the 11 mats to begin the tournament. Before too many matches were over the on-line recording system was able to catch up and keep up with the results.

Numerous people volunteered to keep score for the matches that kept them busy for most of the day. The 8 and under through 14 and under matches were held on mats that covered the fieldhouse floor and two mats in the Junior High Gym handled the high school division matches.

Goodland was fourth among the teams with pins having 22. Greater Gold of Garden City was first with 39, Ulysses was second and Colby was third. Marvin Hernandez led Goodland with 3 pins in his matches.
