nt.betz@nwkansas.com Two Sherman County commissioners met with four city commissioners on Monday at the city meeting to talk about possibly changing and expanding the recycling program, and what do do about an animal control officer with the joint dog pound in operation.

The two commissions agreed to look into possibly renting or leasing a building that might be used to collect cardboard and plastic to be baled and sent to the Northwest Regional Recycling center in Colby.

City Manager Doug Gerber said he and County Commissioner Chuck Thomas recently attended a meeting of the regional recycling organization in Colby.

He said the organization represents a combination of eight counties in northwest Kansas, and charge \$2 per person to join the group. He said the big difference between what the city and county are doing now and the regional group is the regional group accepts plastic and cardboard.

He said the organization suggested the county have a dedicated building for collecting the recycling material and a couple of part time employees for an hour or two a day to handle and bale the plastic and cardboard.

Daniels said the Colorado recycling group charges \$2 per person and if the county wanted to opt out they would have to notify the group by September. He said Sherman County is usually the second or third of the 18 counties in the system taking about 187 cubic yards a quarter to the organizations headquarters in Las Animas, Colo.

The Colorado group has a specially equipped truck and trailer that come to Goodland once a week to empty the containers at Walmart, by Rasure Lumber and by the city shops.

Thomas said it was his understanding the city owns the recycling containers. He suggested staying with Southeast Recycling and going with the regional group for the cardboard and plastic.

Billinger said they would need a large area for cardboard. He said it sounded like both commissions were short of money. He said they might look for a building, and agreed with Fairbanks it would be best if it was all in one place.

Daniels said the other containers could be moved to a single location. He said if the regional people will take the plastic and cardboard they could make it work if they can find a building.

On the animal control officer Gerber said he saw three options.

First, the city hire someone full time and the county continue their contract. Second, the city hires someone and the county contracts with the city. Third, is the city and county jointly contract with someone for the service.

Billinger asked if Larry Harper, who had expressed an interest in doing the animal control for both the city and county, had contacted Gerber.

Gerber said he had not heard from Harper and had not contacted him until after the two commissions had talked about how to handle the animal control.

He said the police are picking up the dogs now, but that is not a good long term option. He said they moved the animals to the joint shelter last week.

Billinger asked the county commissioners if they had an opinion on the options.

Strnad said the county likes the contract they have with Bob Juleson. He has a day job, but charges mileage and a set cost per dog

Gerber said it was a policy decision and was asking for options. He suggested the city could do an advertisement asking for proposals.
