Few complaints on fireworks

nt.betz@nwkansas.com Commissioners on Tuesday heard one complaint about the first year experiment of allowing fireworks to be shot off within the city over the July 4 Independence Day holiday.

Don K. McClain, 524 Cherry Ave., said he was not in favor of allowing fireworks, but thought he could go along with it until he found a tail section of what appeared to be a large firework rocket at the edge of his patio.

"Then I got a little upset," he said as he handed the burned out piece to Commissioner Dave Daniels.

"I wondered what might have happened if this had been smoldering on my roof," he said.

Mayor Josh Dechant said this was the first complaint he had heard.

McClain said he had worked for the city years ago and had been a councilman, and said he understood what the commissioners were trying to do. He said in his opinion the city ought to go back to banning fireworks.

City Manager Doug Gerber said this was the first negative comment he had heard about the fireworks.

"I felt the police had a good approach in handling calls," he said. "The officers gave verbal warnings and said they would not write a ticket unless they had to come back. In most cases the people quit shooting off their fireworks."

Daniels said he had one call about fireworks.CommissionerJohnGarcia said had a call about fireworks.

Dechant said he had not heard any complaints and with all the fireworks being set off he said the sales must have been good.

Chief Ray Smee said Friday the verbal warnings seemed to work. He said the officers were called to several places on Saturday after the 10 p.m. cutoff time, and the rain helped cut them off about 11 p.m. on Sunday.

He said there were a few calls during the week, and the officers went to the addresses and found young kids shooting off fireworks. The officers talked to the kids and their parents. He said the parents told the officers they did not know the kids had the fireworks.

10 a.m. to 10 p.m. on July 3 and 4. and had to move them over. It allows the police to write tickets for shooting off fireworks out side of these hours that would go to the municipal court and can receive a fine of up to \$500.

Gerber said he was sure the rocket found by McClain was not allowed under the definition in the city ordinance. He said he feels it was not bad for the first year, and knows the city will have to do more education next year to make sure people know what is allowed and what is not allowed under the city ordinance.

He said the ordinance does allow a citizen to apply for a permit to hold a larger fireworks display, and in such a case requires the fire chief to inspect the place and equipment to be used to set off the fireworks

"I think it went well for the first year," Gerber said.

nt.betz@nwkansas.com A legal notice running in The Goodland Star-News says lot 6 of the Goodland Energy Center north of Caruso is to be sold at a sheriff's sale at 10 a.m. on Tuesday, July 27 at

the Sherman County Courthouse. Based on the legal description the property being sold is the unfinished coal-fired power plant on the south portion of the energy center.

In the legal First National Bank is listed as the plaintiff and a large list of people who were stockholders in the Goodland Energy Resources, a limited liability corporation, are listed as the defendants.

National Bank said the sheriff's sale is another step in the process to get clear title to the land and equipment to be able to find a buyer for the power plant who would come in and complete the project to get it up and running.

He said the lawsuit was filed some time ago with all the banks involved, but the First National Bank is the lead bank and the only one listed.

He said the two sides agreed to go to mediation in March and all assembled at the Sherman County courthouse where an agreement was worked out.
