Road and bridge budget increases to help control weeds

Nt.betz@nwkansas.com Sherman County commissioners feel spraying the county roads is important, and Tuesday discussed raising the road and bridge chemicals to \$80,000 to help with the road maintenance for next year.

Earlier the commissioners had talked to Darrel Schrader, mowing contractor, about the problems he is running into and decided to delay the second round of mowing. The commissioners told Schrader to concentrate on mowing the intersections before school starts for school bus safety.

When Curt Way, public works manager arrived the commissioners told him about the changes in the mowing plans and he agreed delaying the second round of mowing made sense.

Looking at the road and bridge budget Commissioner Cynthia Strnad asked if \$40,000 for weed control chemicals is enough.

Way said he did not think it was enough. He said Doug Hall, county

He said Hall could spray some of the weeds now and that might help, but it was like spending the money twice to spray and then mow.

Strnad said seeding is a good option, but we are not going to see anything for a time. She said it takes time and the people won't see it happen in one year.

Way said one problem with the road and bridge budget is you have to work on two winters, the one before the new budget starts and then what you have until spring.

Strnad suggested raising the chemical amount to \$80,000 to \$100,000 and hit it hard.

"It will put Hall in the position to make it better and it is good to step up to the plate," Way said.

Commissioner Max Linin said he felt \$80,000 was about right for next year.

Commissioner Chuck Thomas asked if raising the amount by \$40,000

would cover half the county. Way said it would cover about

Srnad said if the money is in the budget and they don't use it all it will carry over to the next year.

Way suggested making it two lines so Hall knows where he is with \$200,000 for roadside maintenance and \$80,000 for chemicals.

Way said the chip seal project will start on Monday, but he was not sure on what part. He said with the better chemicals and rock it is possible the chip seal could last more than five years and the county may be able to stretch it to six or seven years.

Strnad said it appears the road and bridge budget showed an increase of about \$20,000 before the chemicals were increased. She asked about the contractual services figure.

Way said he had it higher, but

Strnad asked about the repairs for the department as the budget is for \$180,000 and the department has used about \$90,000 this year.

Strnad asked about an incident with a truck and losing an engine.

When asked Strnad said a new road and bridge employee was changing the oil in the truck he drove, and apparently forgot to put the new oil in and drove off without it causing the engine to seize.

Way said Steve Goodman, shop foreman, had dealt with the situation, and that it would probably cost \$30,000 or more to replace the engine.

On the other repairs Way said he needs to sit down with Goodman and talk about that. He said there are some things that the department could do repair work on.

James Clift, lives in Canon City, Colo., and he has not had any contact with him. He said he knows Clift received the hearing notice.

He said the fire department did some training in the house a couple of years back, and the last time he talked to Clift he was planning to get it torn out. Right now it is for sale, but it looks like a trash pile. His recommendation was to give Clift 90 days to clean it up or tear it out.

Rick and Mary Mills, who own the foundation at 419 Harrison, were present and told the commissioners they had planned to build a two-story house on the foundation, but had run into problems over the years and were never able to complete the project.

"It sits waiting to be developed," Rick Mills said. "We have been trying to sell it. Have had one offer, but it was not a fourth of what we were asking. The preference is to sell it. The foundation is sound and no sense to tear it out and start from scratch.

"We have done some additional work on the foundation, but our situation has changed. We no longer have family and do not need a twostory house."
