Goodland to be part of convoy

the rumble of the World's Largest Truck Convoy heading on Saturday, Sept. 11 to raise money for Special Olympics Kansas..

Organizer Jane Mentlick of Atwood, said there will be two outlying legs of the convoy this year. The east leg will leave Mitten Travel Plaza in Oakley at 9 a.m. (Mountain Time) and the west leg will leave Wilkens Truck and Trailer in Goodland at 8:45 a.m. (Mountain time). Both legs will head for Colby and join together on Horton Ave. near Oasis Truck Stop.

At 10 a.m., the trucks will form a parade and make a circle of downtown Colby. From Horton they will head north on Range Ave. They will turn right on Fourth Street and head down to Franklin Ave. The convoy will continue on Franklin and turn right on Davis Ave. – by Colby High School – and head west to Range Ave., where they will turn north

Goodland and Colby will hear and head to the Thomas County Fairgrounds.

> After the convoy gets to the fairgrounds there will be a lunch and auction for truckers, athletes and the public.

Bummer and band plays rock, blues, jazz

Bummer the Drummer and the Kansas City Street Band will play at 2 p.m. on Sunday, Sept. 12, at the Goodland High School Auditorium. The group has delighted audiences with the "in the pocket grooves," "hard driving blues shuffles,' "danceable upbeat funk" and some of the best ballads.

Glen "Bummer the Drummer" Ward studied music as a youngster and, along with clarinet, sax, and sousaphone, picked up the drum kit, conga drums, resonator bottleneck acoustic guitar, electric guitar and electric bass. As fate would have it, the drum kit and conga drums turned out to be his predominant instruments of choice, with his guitar work following a close second.

As the story goes, the nickname "Bummer" came from family and friends who gave him the name because of a brief stint he spent as a youngster as a prizefighter. They stole the "Brown Bomber"" nickname from legendary heavy weight champion prizefighter Joe Louis, shortened it to Bomber and immediately corrupted the pronunciation into what we now know as Bummer. Naturally in later years when the drumming and singing came into being, the name "Bummer the Drummer" was the end result.

As 1977 rolled around, Bummer was back in Missouri living in Kansas City where he started his own horn band, "The Kansas City Street Band" consisting of guitar, bass, drums, saxophone,

trumpet and trombone. Bummer and the Street Band worked the Kansas City nightclub circuit and toured extensively throughout the Midwest. The band developed a reputation as a top-notch "rock n soul" act playing cover songs interspersed with originals, mostly written by Bummer. Since The Kansas City Street Band's inception, Bummer and the band have evolved into a dynamic "rock 'n soul" force that has toured all over the country, playing nightclubs, concerts and music festivals.

Energy prices down, affects wind farm developer

25. The bad news about energy prices is that they are down. The good news is that Kansas is a state where investor owned utilities such as Weststar and Kansas City Power and Light are allowed to purchase renewable sources of energy which includes wind energy.

More good news is that the wind farm that has been the works for an area in Thomas County, near Colby since 2006 appears to be on the move.

Forks project will produce 108 megawatts of power with 72, 1.5 megawatt turbines. Construction is expected to begin in 2011. The project should be in operation by the end of 2011 at an estimated \$300 million dollar capital cost.

Expected time of construction is nine months, after a power purchase agreement is signed between Acciona and a power purchaser. Tower height will be 267 feet, with 120 foot long blades for a total height of 387 feet.
