The institutions will use the money to develop innovative programs with private companies that need workers with specific jobs skills or to meet other industry training needs. Northwest Tech will receive \$57,000 to help develop online curriculum for the mobile app development course, said Diane Stiles, assistant vice president for academic affairs. She said the college received the full amount they requested for the program.

Northwest Kansas Technical College, working with Apple Inc.; Eagle Communication; Sparrow Development; Quark Studios; and New Age Wireless will use the money to train workers to become full-time mobile app developers. Individuals may train on-line and access training remotely, leading to IT jobs in rural Kansas.

"There are good companies in Kansas looking for workers, but those individuals must have the

The Kansas Department of Com-right training and skill set," said merce announced it has awarded Kansas Commerce Secretary Pat to expand their business activities and create jobs."

The target for the money is highgrowth, high-wage, and highly skilled occupations with higher than average job vacancy rates or projected growth rates.

The institutions receiving funds have created a plan that includes a strong partnership and alignment with industry and the public workforce system, and integrates the workforce priorities of the state.

"It's critically important to the economic recovery of Kansas that companies are able to find workers with the required skills, and this grant provides another way for individuals to acquire training and re-enter the workforce or advance in their careers," George said.
