A CHARTER ORDINANCE EXEMPTING THE CITY OF KANORADO, KANSAS FROM K.S.A. 75-1122

BE IT PRDAINED BY THE GOVERNING BODY OF THE CITY OF KANORADO, KANSAS:

SECTION 1: EXEMPTION. The City of Kanorado, Kansas, a city of the third class by the power vested in it by Article 12, Section 5, of the Constitution of the State of Kansas, hereby elects to exempt itself from and make inapplicable to the City of Kanorado, the provisions of K.S.A. 75-1122, and make inapplicable the requirement of having its accounts examined and audited by a licensed Municipal Public Accountant or accountants or a certified public accountant or accountants at least once each year as provided in said statute.

SECTION 2: This Ordinance shall be published once a week for two consecutive weeks in the official city newspaper as

provided by law.

Section 3: This is a Charter Ordinance and shall take effect Sixty-one (61) days after the last publication thereof unless a sufficient petition for a referendum is filed and a referendum held on the ordinance as provided in Article 12, Section 5, Subdivision (c)(3) of the Constitution of the State of Kansas, in which case this ordinance shall become effective if approved by a majority of the electors voting thereon.

PASSED AND ADOPTED this 4th day of June, 2012, by a two-thirds vote of the members of the governing body of the City of Kanorado, Kansas.
