# Carnival rules may change

Presently the locally owned carnivals which includes carnivals in Hill City, Hoxie, Colby, Goodland, St. Francis, Sharon Springs, Tribune, Oakley, Ness City, and Leoti, are not required to have Level II inspections on a yearly basis. The State of Kansas is looking

Early last week an external audit revealed concerning details regarding the leadership of the state funded Kansas Bioscience Authority. Based in Olathe, the Authority's primary goal has been to attract

high-tech biological science companies and jobs to Kansas through its partnership with the state. Since its inception in 2004, the Authority has received \$175 million in state funding to carry out this mission.

Over the past year, both the legislature and the executive branch had become increasingly concerned with reports of spending abuse and inappropriate business dealings with the Authority. A full forensic audit was ordered.

Results of the audit, performed by national firm BKD, focused on both the Authority board of directors and former Chief Executive Tom Thornton, who resigned soon after the audit was ordered. The 300 page summary confirmed numerous make sure these rides are safe for our issues under Thornton's leadership including; computer mainframe files. Evidence indicates Thornton may have tampered with files on the Authority's mainframe computer which contained sensitive records only accessible to top level management. However, auditors were

unable to completely prove that tampering occurred because backup copies of the drive are deleted after 30 days.

HB 2412, Dissolution of Treece, Kansas. The bill dissolves any city in Kansas that was bought out or relocated by the EPA during the 2010 and 2011 calendar years. The City of Treece had long been a victim of under mining and contamination by lead and zinc. As a result, residents of Treece were offered a buyout by the EPA to relocate. All the residents took advantage of the buyout except for one

family. The bill passed 122 to 0. HB2436, Time Limit For Certificates of Public Convenience. This bill amends current law to impose 180 day time limit for the Kansas Corporation Commission to act on applications for certificates of public convenience. All common carries or public utilities who want to operate in Kansas must obtain a certificate of public convenience from the KCC. The current law does not impose a deadline for action and unless the utility and the KCC agree to waive the deadline, action must be taken on the certificates within 180 days. This bill passed by a vote

County 3 near St. Francis and Sheridan 6, from Hoxie west to the county line along U.S. 24, including one quarter section in Thomas County.

Bossert said the program could use some more applicants and he worries, with grain prices so high right now, farmers may be reluctant to give up any water.

In Sheridan County, though, the new grant may get the program to the point where people can actually see a difference. To help with that, he said, some grant money will be used to pay for more monitoring wells.

The sign-up period is expected to remain open until mid March, and all money has to be obligated by July 2. The state Water TAP program is expected to have some money available this year for buyouts, but the final amount won't be known until the Legislature sets its budget.

The other three Kansas programs are being offered in District 2 (headquartered in Halstead), District 5 (Stafford) and District 3 (Garden City). These programs are, in addition to encouraging the setting aside of irrigated acres, also encourage water conservation efforts such as increased irrigation efficiency via irrigation system upgrades, and eliminating center pivot endguns.


