Value on specific properties may not follow the general trend because of change in the property, correction of description information or adjustment values based on sales of similar properties.

In accordance with K.S.A. 79-1476, the Division of Property Valuation is required to annually

furnish each county the results of its' study relating to changes, if any, of the use value of agricultural land. Changes can and do occur as a result of several factors including cropping practices, commodity prices and production costs.

The study relating to use value of Agricultural Land completed by the Division of Property Valuation indicated the following changes compared to the prior year:

All Grassland: No change in value on all soil mapping units

Dry Cropland: Increase of \$6.00-\$7.00 per/acre on majority of soil mapping units

Irrigated Cropland: Increase of \$134.00to \$35.00 per/acre on predominate irrigated soil mapping units


