Lots Three (3) and Six (6); Block Three (3); Goodland Industrial Park which is located in Section Twenty-four (24), Township Eight (8) South, Range Forty (40) West of the Sixth Principal Meridian, Sherman County, Kansas. Also known as 601 Industrial Loop.

may appear and show cause why such structure should not be condemned as an unsafe or dangerous structure and ordered repaired or demolished.

BE IT FURTHER RESOLVED, that the City Clerk shall cause this resolution to be published two consecutive weeks in the

official city paper and shall give notice of the aforesaid hearing in the manner provided by law.
