To whom it may concern and to all persons interested:

Notice is hereby given that at 6:00 p.m. on June 14, 2012, the City of Goodland Planning Commission, in the Second Floor Commission Room, at City Hall, 204 W 11th Street, Goodland, Kansas, will consider the following application: Case No. 010612

Zone change from the R-1 (Residential - Single-Family and Two-Family District) to C-2 (Downtown Business District) for property legally described and generally located as follows:

Lots One (1) and Two (2), Block Sixty-one (61), of the Subdivision of the Original Town of the City of Goodland, Kansas, known as 223 East 10th Street.

As provided in the Zoning Code the above amendment will be discussed and consid-

ered by the Goodland Planning Commission, and all persons interested in said matter will be heard at this time concerning their views and wishes; and any protest against any of the provisions of the proposed changes to the zoning regulation will be considered by the Commission. 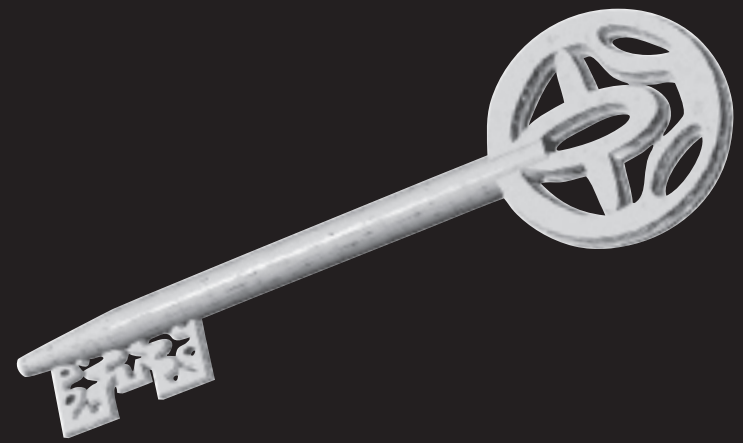
