GOODLAND, KANSAS:

A RESOLUTION FIXING A TIME AND PLACE AND PROVIDING FOR NOTICE OF A HEARING BEFORE THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS, AT WHICH THE OWNER, HIS OR HER AGENT, LIENHOLDERS OF RECORD, OCCUPANTS AND OTHER PARTIES IN INTEREST OF STRUCTURES LOCATED WITHIN SAID CITY AND DESCRIBED HEREIN MAY APPEAR AND SHOW CAUSE WHY SUCH STRUCTURES SHOULD NOT BE CONDEMNED AND ORDERED REPAIRED OR DEMOLISHED AS AN UNSAFE OR DANGEROUS STRUCTURE.

That a hearing will be held on the **2nd day of July, 2012**, before the governing body of the city at **5:00 o'clock p.m. MST** at the City Commission Chambers, 204 W 11th, 2nd Floor; Goodland, Kansas, at which the owner, his or her agent, any lien holders of record, any occupant and any other parties in interest, as that term is defined by law, of the structure located at:

Lots Seven (7), Eight (8) and Nine (9), Block Thirty-seven (37), Beahm fs Addition to the City of Goodland, Kansas according to the recorded plat thereof. Also known as 504 East 7th

may appear and show cause why such structure should not be condemned as an unsafe or dangerous structure and ordered repaired or demolished.

BE IT FURTHER RESOLVED, that the City Clerk shall cause this resolution to be published two consecutive weeks in the official city paper and shall give notice of the aforesaid hearing in the manner provided by law.

Notice is hereby given that at **6:00 p.m. on June 14, 2012**, the **City of Goodland Planning Commission**, in the Second Floor Commission Room, at City Hall, 204 W 11th Street, Goodland, Kansas, will consider the following application: Case No. 020612

Zone change from the R-1

(Residential -Single-Family and Two-Family District) to R-2 (Multi-Family Residential) for property legally described and generally located as follows:

Lot 4 (4), Block Seven (7), of the Westmoor Acres of the City of Goodland, Kansas, known as 8th and Grandview.

As provided in the Zoning Code the above amendment will be discussed and considered by the Goodland Planning Commission, and all persons interested in said matter will be heard at this time concerning their views and wishes; and any protest against any of the provisions of the proposed changes to the zoning regulation will be considered by the Commission. Property owners within 300 feet of such property described above wanting to protest the proposed change will have fourteen days after the Planning Commission makes its recommendation regarding the requested rezoning to submit a protest petition to the office of the City of Goodland City Clerk. If a valid protest petition is filed with the City Clerk prior to the

deadline, the change shall only be approved by a unanimous vote of the City Commission. Protest petitions are available in the Inspection and Code Enforcement Department of the City of Goodland.

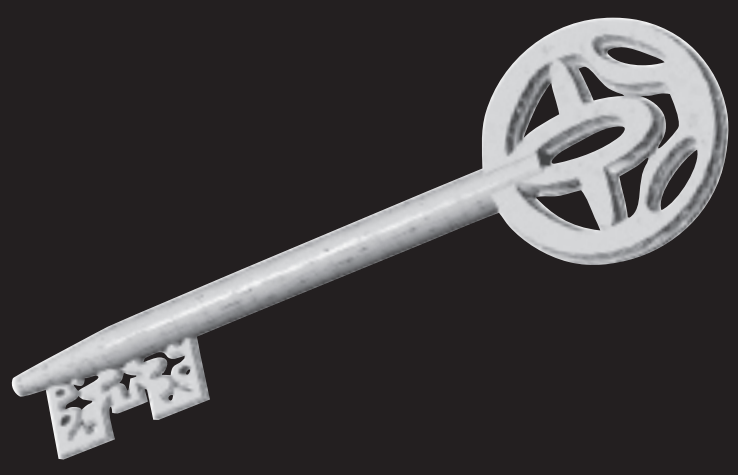
