Zucchini Garden Chowder

Ingredients

- 1 chopped onion
- 2 chopped zucchini
- 1 tbsp. minced fresh parsley
- 1 tsp. dried basil
- 1/3 cup butter or margarine 1/3 cup all-purpose flour
 - pinch of sugar • 1 (12 oz.) can evaporated milk

• 3 chicken bouillon cubes

• 2 cups shredded cheddar cheese

- 1/2 tsp. black pepper
- 1 tsp. lemon juice • 1/4 cup grated Parmesan cheese (optional) • 1 (14 oz.) can diced tomatoes
 - 1 (10 oz.) package frozen corn, thawed
 - 1 tsp. salt
 - 3 cups water

Saute the first 4 ingredients in the butter in a dutch oven. Stir in the flour, salt and pepper and mix well. Stir in water gradually. Add the bouillon and lemon juice and mix well. Bring the mixture to a boil and cook for 2 minutes, stirring constantly. Add the tomatoes, evaporated milk and corn and return to a boil. Reduce the heat, cover and simmer for 5 minutes. Add the cheeses and sugar, stirring until the cheeses are melted. Yield 8-10 servings.
