Judge ruled as to qualifications of jury members for Dewey trial today in history By Evelyn Ward children and asks that she receive death. Daniel Berry picked him up ness in Denver.

Sherman County Historical Society Feb. 13, 1904: Jury In Dewey Trial In Sight — Judge Geiger Makes Ruling As To Qualifications of Veniremen — The Reading of Newspaper Reports of the Dewey-Berry Tragedy Does Not Necessarily Disqualify Them — Trial to Begin Soon — The latest information from Norton, where Chauncey Dewey, William J. McBride and Clyde Wilson are being tried for the murder of Burchard B. Berry, says that it is probable that the finding of a satisfactory jury will be finished by Friday unless something unforeseen happens.

The case was given impetus early this week by a ruling of Judge Geiger, who said in response to a challenge for cause by Attorney Morlan for the defense: "The challenge is overruled, and I want to say that the time, if not here, will be very soon when newspaper reports alone will not disqualify a man to sit as a juror in any criminal case.

"If it does, it will drive us to those who are less intelligent, because they do not take the newspapers of the country, and are therefore not

well informed on current events.

Feb. 15, 1904: General Colby's interest in the Dewey case goes deeper than the fee he is to receive from the commissioners of Cheyenne county for his work.

About two weeks ago, Fred Dawson came down from Denver, and the matter of buying in on the Dawson store was then considered. The deal having later taken a more definite form was agreed upon and the transfer made this week.
