Next, Paul Gleason, director of Sherman County's emergency medical service, testified, saying he and another medical technician examined Carrie Bevington and found no signs of life. He said they left the body and the pickup alone. On cross-examination, Gleason said he was not a medical doctor or a coroner and could not declare someone

After a short recess, Agent Robbins was called in to testify. She said Bevington originally told officers that he might not have fully un-

loaded the gun earlier and that when he was removing it from the pickup, the wind closed the truck's door knocking the gun from his hand. When he reached to grab it, he said, his finger hit the trigger.

# School board to consider third option School board, from Page 1

mended that the board add 10 percent to both estimates for contingencies.

Board member Mike Campbell said the money used for a new building could be wasted if sometime in the future the district built a new football stadium. He asked about the possibility of using the restrooms in the high school during football games and renovating them to handle the potential traffic increase. That way, he said, the space freed under the stands can be used for other things.

Board member Marty Melia said the district could save a lot of money if the cafeteria was used as a concession area during games instead of paying for a new building or major renovations. He said renovating the restrooms in the high school would also save money and asked the board to consider those ideas as a third option.

Board President Dick Short said this would be one way to "kill two birds with one stone" by bringing the high school's restrooms into compliance with the Americans with Disabilities Act and make them capable of handling the increased traffic.

Marvin Selby said the number of student's in the district dropped by 10 in March, for a total of 19 for the school year. He also said federal funding for the district next school year will be about \$22,000 less than this year. Selby said this would require taking more money out of the general fund for salaries and cutting some in-service teacher training.

Selby briefed the board on a school finance bill in the Legislature and its potential impact on Goodland. The bill would put a surtax on state income taxes, he said, and the district could gain \$330,000 in the first year under the bill.


