The Goodland Star-News The question of how many lights to illuminate the giant Vincent Van Gogh painting remains, but the city commission gave approval for the project Monday and agreed the city will provide the electricity.

Larry Keirns, representing Goodland Rotary Club, was back to ask the commissioners if they would approve the project.

City Manager Ron Pickman had a map of the area for each commissioner, and the location of the lights would be outside the area leased to the Sunflower USA group by about 18 feet.

Keirns said he had talked to the group and was told that Cameron Cross, the Canadian artist who painted the Van Gogh replica, had wanted lights to draw attention to the painting.

Commissioner Dean Blume said he thought it would be good to light the painting, but was not sure he liked the idea of the 10-foot pole out in front because it might interfere with the view for those who stop to photograph the scene.

"I would rather have two if they can be on shorter poles which can be hidden with landscaping,' Blume said.

Pickman said there are no definite plans for the area, but that several groups have approached the city about the property. He said it was not likely anything would be built in front of the painting.
