The Goodland Star-News Goodland has agreed to join with 11 cities as the Northern Regional Training Group to hold monthly safety training session for city employees next year.

City Manager Ron Pickman told the city commission last Monday that the group is forming through the Kansas Municipal Utilities, and the training will be one day a city workmen's compensation insurance month in each of the 12 cities. If a city employee misses a session in one city they can insurance carrier said it might be June beattend in one of the other members that month.

The estimated cost for the program is \$8,256 if all 12 agree, but that could go up to \$10,000 if one or more of the cities drops out. The cities involved are Goodland, Colby, Russell, Clay Center, Wamego, Larned, Holton, Hoisington, Herrington, Sabetha, Belleville, Oberlin and Washing-

• Pickman said that Bill Easton, who lives in Hebron, Neb., was asking the city to participate in a drainage ditch project on his property in the northeast part of the city, and expects the cost to be less than \$3,000. However, the ditch won't be built this year, Pickman said. A section of trees had to be removed along the eastern part of the field, and Easton wants to know if the city would help pay for that. Pickman said the trees have already been removed, and said he doubted if the city would help pay because they did not have any choice in how it was done. The commissioners agreed the city could not help pay for the trees, but wanted to be sure Easton? knew the city would help with the ditch. 

Commissioner Kevin Rasure. "We need to let them know what you need to do a little more of that. need and let them know who you are calling for.

"We are not saying buy local at any price, but we want to be fair and give them a chance where possible.'
