

**ORDINANCE NO. 1520**

**AN ORDINANCE ATTESTING TO AN INCREASE IN TAX REVENUES FOR BUDGET YEAR 2005 FOR THE CITY OF GOODLAND, KANSAS.**

**WHEREAS**, the City of Goodland, Kansas must continue to provide services to protect the health, safety, and welfare of the citizens of this community; and

**WHEREAS**, the cost of providing essential services to the citizens of this city continues to increase; and

**WHEREAS**, the Kansas Legislature has eliminated demand transfers to local governments; and

**WHEREAS**, the Kansas Legislature failed to reinstate these demand transfer payments to local governments; and

**WHEREAS**, the Kansas Legislature has failed to provide local governments with authority to raise necessary revenue from other sources;

**NOW THEREFORE**, be it ordained by the Governing Body of the City of Goodland, Kansas:

**Section 1.** In accordance with state law the City of Goodland, Kansas has conducted a public hearing and has published the proposed budget necessary to fund city services from January 1, 2005 until December 31,

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS:**

**Section 1. INCORPORATING UNIFORM PUBLIC OFFENSE CODE.** There is hereby

incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Goodland, Kansas, that certain code known as the "Uniform Public Offense Code," Edition of 2004, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Uniform Offense Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1521," and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours.

**Section 2. REPEAL.** Ordinance 1507 is hereby amended and repealed.

**Section 3. EFFECTIVE DATE.** This ordinance shall take effect and be in force from and after its publication in the official city newspaper.

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS:**

**Section 1. INCORPORATING STANDARD TRAFFIC ORDINANCE.** There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Goodland, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordinance for Kansas Cities," Edition of 2004, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1522," and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

**Section 2. REPEAL.** Ordinance 1506 is hereby amended and repealed.

**Section 3. EFFECTIVE DATE.** This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
