ORDINANCE NO. 1523

AN ORDINANCE ESTABLISH-ING A CODE OF PROCEDURE FOR THE CONDUCT OF CITY COMMISSION MEETINGS OF THE CITY OF GOODLAND, KANSAS: INCORPORATING BY REFERNECE THE "CODE OF PROCEDURE FOR KAN-SAS CITIES," FIRST EDITION (2004), WITH CERTAIN OMIS-SIONS, CHANGES AND ADDI-TIONS.

BE IT ORDAINED BY THE GOVERNING BODY OF CITY OF GOODLAND, KANSAS:

SECTION 1. INCORPORAT-ING CODE OF PROCEDURE FOR KANSAS CITIES. There is hereby incorporated by reference for the purpose of establishing a code of procedure for the conduct of city commission meetings of the City of Goodland, Kansas, that certain model code known as the "Code of Procedure for Kansas Cities,' First Edition (2004), prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas save and except for such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed.

SECTION 2. OFFICIAL COP-IES. At least three copies of the "Code of Procedure for Kansas Cities" shall be marked or stamped OFFICIAL COPY AS INCORPORATED BY ORDI-NANCE NO. 1523, with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance. All official copies shall be filed with the city clerk to be open to inspection by the public during all reasonable business hours. Official copies of the "Code of Procedure for Kansas Cities" shall be furnished to all persons or departments charged with the enforcement of the code or to whom the Code is applicable and to such others as may be deemed necessary. All

such copies shall be furnished at CITY, from Page 1 the cost of the city.

SECTION 3. Sections 32,33,34,35,37,39, and 40 of the "Code of Procedure for Kansas received an application from Lut-Cities" relating to the Council Form of Government are hereby declared to be and are omitted and deleted.

SECTION 4. Section 12 of the Page 3. "Code of Procedure for Kansas Cities" is hereby changed to read as follows: Order of Busi**ness.** At the hour appointed for the meeting, the mayor shall call the meeting to order. In council cities, the president of the council shall chair the meeting in the absence of the mayor. Upon having a quorum present, the governing body shall proceed to business, which shall be conducted in the following order:

I. Approval of the minutes of the last regular meeting and inter-

vening special meetings; II. Presentations of petitions, public comments, memorials; III. Presentation of claims and

appropriation ordinances: IV. Unfinished business; V. New Business;

VI. Reports of staff and commit-

VII. Consent Agenda; VIII. Commissioner's Reports; IX. Mayor's Reports; X. Adjournment

SECTION 5. EFFECTIVE

DATE. This ordinance shall take effect and be in force from and after its publication in the official newspaper of the City of Goodland, Kansas.
