County may raise property tax 2 percent

The Goodland Star-News The preliminary budget probably would raise the county property tax rate by 1.32 mills, or about 2.2 percent, County Clerk Janet Rumpel told Sherman County commissioners at their meeting Tuesday.

Last year, the county had an increase of about 10 mills, or about 20 percent, in the rural property tax rate. The total county tax levy was 58.673 mills plus 5.164 for the rural fire district. Rumpel said the new tax levy would be 59.991 and the fire would be 3.469, and that would mean a total drop in county property taxes.

She said the total of the two property tax levys will drop, and the people in the city will not see the rural fire district tax levy.

Rumpel said she had included all the budgets from the departments, and nothing had jumped up higher than expected. She told the commissioners she had put \$60,000 in the bond and interest fund in case they were planning to do some work on the county buildings.

She mentioned the brick work on the courthouse which has not been Rumpel said she had increased done, work on the former Southwest Bell building the county owns.

Questions raised about new fire signs

The Goodland Star-News Signs allowing "authorized personnel only" have appeared in the rural fire station in Goodland, and there was a question at Tuesday's Sherman County commission meeting about who is authorized.

Dennis Bentzinger of Med Enterprises Fire Extinguisher of Salina). said he had noticed the signs, but figured he was authorized because he had a contract to service the county's fire extinguishers.

Commissioners Kevin Rathey did not know anything about the signs. Commissioner Mitch Tiede said he thought Fire Chief Kenny Griffith put the signs up. The commissioners agreed Bentzinger would be authorized because of the county contract.

Griffith said Thursday an insurance company representative recommended the signs because of liability concerns.

"He said the fire station is not a 'public access' building like the courthouse," Griffith said. "Authorized personnel are the firefighters and those who are in company of a firefighter."

Griffith said he did not know if signs had been put up in stations at Kanorado or Brewster.

Bentzinger said he had keys him access to the fire stations, and he has had them since he began doing the fire extinguishers.

"I want to let you know that I am supplying the extinguishers for the fire schools," he said, "and I had fire extinguishers that could have been used at the demolition derby.

'That cost the county about \$200 for the extinguishers used to put out the car fires."

Bentzinger went on to complain about recent county purchases of fire safety equipment.

"I haven't got to bid on anything, and I noticed there was \$4,000 spent with my competitor (Weis Fire Safety Equipment

Bentzinger said he had asked Griffith if the powers above were sure and Chuck Thomas said Public Works Manager Curt Way or Commissioner Tiede.

"I want to keep the cost down," Bentzinger said. "I want to have a chance to bid on the equipment."

Tiede said he did not know of anybody above Griffith who would be the "powers above" and Way said he had nothing to do with ordering fire equipment. That it was up to Griffith, he said. "We can visit with him," Com-

missioner Kevin Rasure said.

The other commissioners agreed and asked to have the fire chiefs and the fire board put on the agenda for the Sept. 7 meeting.

Bentzinger said some of the fire extinguishers in Brewster were missing.

Rasure said the county has an and a combination that allows inventory of what is to be there and they will look into getting it updated by the new fire chief there, Mike Schultz.

When the fire board comes to the meeting, the commissioners said, all the fire chiefs should come to review their operations and make sure everybody is on the same page.
