ber 7, 2004 at 11:30 a.m. (MDT)
in the Commissioners Room of
the Sherman County Court-
house, 813 Broadway,
Goodland, Kansas, for the pur-
pose of considering an applica-
tion to be submitted to the Kan-
sas Department of Commerce
for Small Cities Community De-
velopment Block Grant funds
under the Community Facilities
category. A specific project appli-
cation to be discussed is the pur-
chase of a new pumper/tanker
fire truck with necessary equip-
ment for the Sherman County
Rural Fire District #1 in an area
generally bounded by the ser-
vice area of the Sherman County
Rural Fire District #1. The esti-
mated project cost is \$175,475

with the grant request for
\$92,975 of the project cost.
