will not pay the fee to us, but to the county where the billing is." She said the new equipment will be the same as in Thomas County and allow them to cooperate more closely. SBC Corp., formerly Southwestern Bell, will handle the phone lines, she said, and the cost of the lines is going down a bit in the next year.

Commissioner Mitch Tiede asked how long the system is expected to last. Messamore said she had no idea, but that the current 911 equipment was purchased in 1991

Rasure asked if all the cost of installation were included in the project, and Messamore said she thought she had covered everything. She said it should be in-

stalled in about six months. The grant gives the county one year to complete the project.

She said she is working on another grant to upgrade the mapping system.

Once the commissioners approved the 911 upgrade project, they asked Messamore about her staffing. She said she is at full staff based on her budget.

Rasure said he thought it would be good for the dispatchers to pursue more outside training.

Messamore said with the number of people she has, training creates scheduling conflicts, but agreed they are encouraged to go to training when possible.

She said she has brought in \$290,000 in grants for the dispatch and emergency management programs, and that it takes time to complete these projects.

"It takes away from these when I have to work more hours in dispatch," Messamore said.

Tiede asked about having a fifth full-time person to help give the system more flexibility and allow for more outside training.

Messamore said training is available, and has been in the past, but that the people have not shown interest in going.

The commissioners asked if the present dispatchers rotated shifts. Messamore said the shifts are pretty much set, and her people do not want to rotate them.

"They like the shifts they have," she said.
