

Colby club members display at Carnegie Arts Center

The Carnegie Arts Center will feature the work of eight artists, members of the High Plains Arts Club of Colby, through Friday, Oct. 29.

Several Colby-area artists were inspired to organize an art club after helping Kenneth Mitchell to paint a mural at the new Bedker Hall on the campus of Colby Community College.

In September 2003, Marj Brown organized the first meeting of the club which has grown to 12 members and has exhibited its work in three shows.

In the club's first show during the Celebration on the High Plains at South Wind Plaza in Colby, the members offered nearly 100 paintings. Since then, the club has exhibited at Colby Community College and the Prairie Museum of Art and History in Colby.

Members meet on the second Tuesday of each month from September through May to work on projects and learn more about famous artists and their works. Those who will be showing at the arts center include:

• **Jo Bricker** is a self-taught artist who says she paints for her own enjoyment. She prefers acrylics but also works in oils and watercolor.

• **Brown**, the club secretary, studied art at Colby Community College. She has created murals at the college and at the Prairie Senior Living Complex, a nursing home in Colby. She has worked as an illustrator and as a reporter for the former *Prairie Drummer* newspaper. She works in watercolor, oil and graphite and enjoys creating paintings of people and animals.

• **Marlene Carpenter**, club president, studied art at Colby. She is known in the area for her sunflower paintings and was one of the 12 northwest Kansas artists asked to decorate a chair for the annual public television auction. She was asked this year to decorate a table for the auction.

• **Margaret Denneler**, the club's vice president, also studied art at Colby college. She was among the artists who painted murals at the college and at the nursing home. She prefers to paint with oils and

enjoys creating landscapes.

• **Ruth Hughes** is a self-taught artist who has worked mostly in pencil. She joined the arts club to expand her experiences as an artist and to work in new media.

• **Bev Kern**, the club's treasurer, studied art at the college. She paints in several media but prefers oil. She enjoys studying the history of places she paints and favors landscapes.

• **Fritz Ostmeyer** also studied at the college and teaches painting at the Senior Progress Center in

Colby. She paints in several media but prefers oil landscapes.

• **Lillie Plummer** studied art at Colby and has done many of her paintings while traveling around the country with her husband. She prefers to work in oil and paints landscapes, still lifes and people.

S&T Telephone and S&T Communications are sponsoring the gallery show. Hours are 10 a.m. to 5 p.m. Tuesday through Friday and 1-4 p.m. Saturday, Sunday and Monday. The center is at 120 W. 12th Street in Goodland; admission is free.
