The tax levy authorized by this resolution may be made, unless a petition in opposition to the same, signed by not less than ten percent (10%) of the qualified electors of the school district, is filed with the county election officer of the home county of the school district within forty (40) days after the last publication of this resolution. In the event a petition is filed, the county election officer shall submit the question of whether the tax levy shall be authorized to the electors in the school district at an election called for the purpose or at the next general election, as is specified by the board of education of the above school district.
