Notice is hereby given that pursuant to K.S.A. 25-2018b, a regular school election to elect three (3) board members will be conducted in Unified School District #352, Sherman County, State of Kansas, on April 5, 2005.

This district will be electing three (3) board members from the district at large. Each candidate shall be a qualified elector of the Unified School District #352. Voting Plan "A" will be used whereby the members of the Board of Education will be elected at large and all qualified

electors of Unified School District #352 will be allowed to vote for all candidates. All board members will be elected for a term of four (4) years beginning on the 1st day of July, 2005.

Candidates shall file for such office with the County Clerk of Sherman County. Every such filing shall be made before 12:00 o'clock noon, Tuesday, January 25, 2005. Each such filing shall be accompanied by a filing fee of five dollars (\$5.00) or by a petition signed by fifty (50) qualified electors residing in the school district. No candidate shall be permitted to withdraw his candidacy after the last day provided by law for the filing of such candidacy.

Notice is further given that if more than six (6) candidates file for the board, there will be a primary election conducted on March 1, 2005, in the district. If a primary is held, the six (6) candidates receiving the highest number of votes for such position at the primary election shall be placed on the ballot for the regular school election to be held on April 5, 2005.
