Chamber plans to beautify city in April

The Goodland Star-News After emptying your closets and cleaning out old cupboards, people in Goodland are being encouraged to spread spring cleaning to their lawns with a city-wide clean-up planned in April.

Tuesday, Ken Clouse, Goodland Area Chamber of Commerce board beautification committee chairman and president of the Northwest Kansas Technical College, showed the board maps and laid out plans for the events scheduled for Saturday, April 2, 16 and 23.

He said the city commission Monday approved issuing a proclamation to name April as clean-up month after seeing a presentation put on by Christie Rasure and Arlo Hansen.

The city has agreed to come up with three trucks and three drivers to help the clean-up cause, he said.

The county commissioners said Tuesday they will try to find two trucks and agreed to wave some fees people to clean up their own yards for refrigeration and tire disposal to and take items to the dump themmake the clean-up easier.

Clouse said Dan Brenner Ford Mercury, Goodland Greenline and some construction companies have agreed to help out.

"We've got really some great participation," Clouse said.

The plan for the project, he said, is to split up five teams that will travel from south to north and east to west to cover the entire town from 9 a.m. to noon on the designated Saturdays. Each team will be assigned trucks to haul the trash.

The first Saturday, he said, the I-70 exit to the intersection of K-27. groups will be picking up construction debris and the second will be set aside for tree limbs and metal.

Clouse said they will encourage selves. Those who can't are asked to bring the items to be thrown away to the front of their houses near the curb.

The groups will then pick up the items, fill the trucks with the debris and then haul the trash to the transfer station north of town.

On the third Saturday, he said, the groups will fan out to clean-up highway entrances. The project will encompass K-27 from W. 31st Street all the way underneath I-70 to 8th Street. Clouse said workers will fan out along US 24, cleaning from the

Volunteers will pick-up on Caldwell from 8th Street to US 24, too.

"We'll try to cover the entire community," he said. "That's gonna take quite a few people."

He wants to get the word out to enlist volunteers and get residents more involved in picking up their homes. Clouse plans to put notices in every church, business and organization newsletter. Chamber manager Courtney Warden will send out fliers with the Chamber newsletter and board member Karen Ginther suggested putting more fliers up at businesses around town.

'April second is really just around the corner," Clouse said adding the Chamber and other groups to spread the word.
