Dale H. Murphy, 79, a retired Goodland con-

tractor, died Thursday, March 10, 2005, at St. Anthony Central Hospital in Denver. He was born

Oct. 11, 1925, at Seibert, Colo., the son of Coleman E. and

Mattie B. (Wilmoth) Murphy. The ninth of 10 children, he was raised on the family farm south of Seibert. He attended school at Rock Cliff, south of Seibert, and at Seibert High School.
