# Murder, civil cases were in district court

## **By Evelyn Ward**

Sherman County Historical Society June 29, 1905: Cases In District Court — One Murder and 83 Civil Cases—John Anderson to be Tried for Killing James Hill — Berry's Big Damage Suits Against Deweys Included in Civil Cases — The next session of the district court for Sherman County convenes in Goodland July 3 and will likely adjourn until Wednesday on account of the Fourth of July coming on Tuesday, which breaks into the work of the court.

The civil docket records 83 cases, none of which, save three or four, are of more than passing importance, except to the parties of the litigation. For the most part, they consist of actions for the foreclosure of real estate mortgages and quieting of title of land.

The criminal docket presents one case, that of the state of Kansas vs. John Anderson, the Negro, who slayed his fellow workman, James P. Hill, with an ax in a box car at the railroad the fore part of May.

John Hartzler is defendant's attorney, and he will be assisted by G.W. Jones of Hill City. The gang of Negroes employed on the coal chute at the time of the killing have gone hither and thither, as such class of workmen usually do, and just what witnesses will be available when the case comes up for trial is not generally known.

June 30, 1905: Important Civil Cases — Echoes of the Berry tragedy will be heard at this session of the court.

and administratrix of the estate of Alpheus W. Berry — both of these men having been killed in the Dewey-Berry fight — are each maintaining a damage suit against Chauncey Dewey and his men for the sum of \$10,000 to partially compensate them for the loss of their husband's support.

Roy Berry, who was severely wounded in the same fight, is suing the same parties for \$6,000.

L.W. Colby of Beatrice, Neb., is the attorney for plaintiffs in these three cases. He is an able lawyer, and from his former noted cases in the district court of the county, Mr. Colby is quite well known here. Waters & Waters of Topeka are Dewey's attorneys.

Another case involving the ownership of much real estate property in Sherman County is that of Gertrude M. Dewey, widow of C.P. Dewey, deceased, against the C.P. Dewey Land and Cattle company.

Mrs. Dewey brings action to recover 1/2 of the Dewey company's real property in this county, which consists of more than 100 quarter sections of land. None of this property was bequeathed to her in her husband's will, and she is maintaining this action by virtue of the provision of the Kansas statute, which gives the wife in such cases the right to a 1/2 interest in real property.

## Prostrate spurge is difficult broad leaf weed to control

Prostrate spurge is one of the more difficult broad leaf weeds to control. It is a summer

annual that must come up from seed available to homeowners. every year.

If caught when young, it is easier to control, but even young plants have proven difficult to kill. Herbicide selection is important. Mature crabgrass control. plants are almost impossible to control, even with the best herbicides.

Several years ago, Kansas State Research and Extension conducted a study on the phytotoxic effects of certain herbicides on buffalo grass. During the application, we noted the presence of a large number of small prostrate spurge plants.

As the study progressed, plots were rated for percent control of spurge. The results were interesting. We found that Drive provided more than 90 percent control but is available only to commercial users.

However, Dimension and Turflon Ester offered more than 80 percent control, and Trimec 78 percent. All three of these herbicides are
