Stories behind 'Living Room' are part of art display

As you stand before "The Living Room," the display at the Carnegie Arts Center this month, a chair with tree roots for legs, green satin upholstery and giant wings is on the right side, a couch with clocks on the ends of the arms is dead center, and a throne covered in purple satin and faux Dalmatian fur sits to the left.

Your eyes go a million directions at once, taking it all in, but still, there's more than meets the eye.

The exhibit, by Sunni Mercer, is made from discarded items and is symbolic of the organizations that helped with the works. Besides the furniture, the exhibit includes interactive projects, a scrapbook of how the pieces came to be and a video of the artist telling about the project and its meaning.

The "Velcro Chair" sits behind the living room group and has cards with words, leaves, pictures and pieces of fabric that can be arranged any way you wish.

Next to the chair is a table with materials to make collages, which visitors can take with them, and to decorate puppets. It's really fun for families to come in, said center Director Tina Goodwin.

The scrapbook tells the stories of the pieces, made by Mercer and people from several Wichita organizations at several sites in the city, and then displayed in the Wichita Art Museum.

On the video, Mercer says the project is about redemption; it's made from reclaimed materials.

Mercer said she likes to take things that are discarded, such as a bottle cap crushed on the road, and elevate them into a work of art.

The "Legacy of Memories Sofa" was made with help from Senior Services Inc. and members of the Wichita Art Museum and the Kansas African American Museum. It has pictures on the upholstery and stories on the arms from members of Senior Services and the African-American museum.

The inspiration and help for the "Affirmation Seat" came from Roots and Wings, an organization that helps youths, and was made at Botanica, the Wichita Gardens. Affirmations are written on the wings, and there is a harness that children who sit in the seat can pull over their heads, allowing them to sprout wings.

Rainbows United Inc. helped with the "Right Foot Stool." Adorned with rainbow colors and crystals that represent frozen tears, the stool was made at the Sedgwick County Zoo.

The "Illuminate Me Lamp" includes original drawings from children from the Childcare Association and was made at the South Branch YMCA. The "Reclamation Throne" was made at the Central Wichita Public Library with help from the Inter-Faith Inn.

The "Two-Squared Coffee Table" was made by Urban League and Wichita Art Museum members at Exploration Place. The Urban League trains students on computers and uses a networking approach, matching people with the services they need.

Mercer said she likes to use "gemstone" colors because "these organizations are gems."

After being in the Wichita Art Museum, the works traveled to Topeka, Salina and Emporia. They will be at the arts center through Saturday, Sept. 10. After that, Goodwin said, the pieces may be displayed by the organizations that helped make them.

Dear Attorney General Kline: A company I am currently doing business with has now requested my Social Security Number for their records. I trust this company, but I'm leery about giving out my personal information because of the possibility of identity theft. What advice can you provide?

If you are the unfortunate victim you and never have of identity theft, you should do these four things immediately: 1. Contact the fraud departments of each of the three major credit bureaus and report that your iden-

tity has been stolen. Ask that a "fraud alert" be placed in your file, as well as a victim's statement asking that creditors call you before opening any new accounts or changing existing accounts.






