either by first class United States mail addressed to office of the city clerk of the city or by personal delivery of the same to the person, of his duly authorized agent for receiving the same, and if the notice be addressed to the franchisee, the same shall be delivered by either first class United States mail addressed to the General Manager of the franchisee, or by personally delivering the same to such person as hereinabove provided.

Section 22. Severability. If any section, paragraph, sentence, clause, or phrase of this ordinance is for any reason held invalid by the decision of any court or regulatory body of competent jurisdiction, such decision shall not affect the validity of the remaining portions. The validity of any portion of this ordinance shall not abate, reduce, or otherwise affect any consideration of other obligation required of the franchisee.

Section 23. Effective date. This ordinance shall take effect and be in force from and after its publication in the Goodland Star News, but not before sixty (60) days after its final passage all pursuant to K.S.A. 12-2001 (b)(6).
