## Oakley meat man butchered own music

Sherman County Historical Society October 21, 1905: (Kansas City Journal) - Do Their Own Butchering — John Anderson of Oakley didn't make much of a success as a butcher, so he sold out his meat shop and has opened a music store.

"Country people can kill their own meat," he said, "but they can't make their own musical instruments; still they can butcher music.'

October 22, 1905: Forgery — A Rock Island pay check issued to C.U. Congdon for the amount of \$108.85 was cashed at the Goodland State Bank by some man unknown to Cashier Wolfe. But whoever he was, he was not Charles Congdon.

The crime was discovered about fifteen minutes after it was committed, but the stranger who forged Congdon's name can't be found. Congdon says he missed his pocketbook and its contents, including the check, this morning.

October 23, 1905: Two Fist Fights to Attend to in Sapp's Court Goodland kept pace with the reputation of a tough end district in a big city for about twelve hours last week, but sagged back to her peaceful course because she couldn't keep up the sprint.

The first combatants that commanded the attention of Police Judge Sapp were Louis Frydendall, a locomotive fireman, and R.N. Halstead, who has charge of the bowling alley. The trouble began to

brew at a dance the night before when it is claimed that Halstead kicked a dog belonging to Ernest Moffat.

Moffat's pugilistic representative the next evening was young Frydendall, who started to whip Halstead, but before the first round was up, Marshal Derby grabbed the "pugs" by the napes of the neck from where they were rolling on the floor and marched them to police judge quarters, where Frydendall was fined \$5 and costs and Halstead \$1 and costs.

But judging from results, that encounter was tame compared with what B.W. Greenlee, a locomotive fireman, and P.L. Wright, a brakeman, thrashed out on the ground back of Dad Auer's place Saturday forenoon.

Wright has not yet been able to appear to talk the mater over with the police judge, but Greenlee was arraigned before the police court with a hearing Monday morning.

County Attorney Calvert modified the charge, changing it from assault and battery with intent to do great bodily harm, to plain assault and battery. Greenlee pled guilty to this and was fined \$8 and costs. Wright will probably be brought before the court, after he gets a little more presentable, and fined for disturbing the peace.

the two men was not brought out in the court, but the report is that the men had all along been on good terms but they got into a disagreement and words came up between them and blows, sledgehammer blows, followed.

Greenlee had one eye hurt and a tooth knocked out, but Wright was badly punished. His face was beaten and bruised so badly that he had to be fixed up at a doctor's of-

fice. He was unconscious for several hours, and his appearance indicated that he had been "pushed in the face."

Greenlee and Wright are both powerful men and, when such fellows lose their tempers, they little realize the grave danger that lies in a blow with a couple of hundred pounds behind it.


