# Interviews planned for top 911 applicants

The Goodland Star-News Sherman County commissioners are planning to interview the top five candidates for central dispatch director over the next 10 days and hope to make a decision at their next meeting on Wednesday, Nov. 30. Commissioner Mitch Tiede said the county received seven applications for the job and has decided to interview the top five. Commissioners Kevin Rasure and Chuck Thomas agreed to try to call a couple of the candidates each to set up interview times. The commissioners spent 15 minutes in closed session talking about the applications before announcing they would interview the top five. Among the finalists are Crissy Conger, the interim central dispatch director, and Rita Hill, wife of City Manager Wayne Hill, a police lieutenant who is the dispatch director in Guymon, Okla. The commissioners talked to Conger and Rita Hill before Mary Messamore, former central dispatch and emergency management director, resigned to move to Hutchinson. Tiede refused to say who the other three candidates are, except that all live within 100 miles of Goodland. He said that none of the applicants has had much experience working with the emergency management job, but an interim agreement with Cheyenne and Rawlins counties to share a director could take care of

Sherman County commissioners decided Tuesday not to finance three county projects, but to take the money out of the reserves and save the cost of the interest.

The county has been discussing financing its share of the new bridge on County Road 65 (Eighth Street) of \$83,000; repairs to the brickwork at the courthouse, \$76,000; and the remaining \$278,000 for a baler and conveyor at the trash transfer station.

Commissioner Mitch Tiede said the county needed to decide how to pay for the baler before the final payment sneaks up on them.

Commissioner Kevin Rasure asked County Clerk Janet Rumpel and assistant Clerk Mary Ann Snethen how much had been put aside for the baler project and how much was in the solid waste reserve.

Snethen said the county had put aside \$278,000 for the baler and conveyor plus \$8,000 for the freight. She said money also had been put on hold for the building addition and doors at the transfer station to house the baler.

She told the commissioners that \$58,000 had been paid in May, 20 percent of the cost of the baler and

the conveyor. The total invoice for the baler and conveyor was \$328,000. The agreement calls for another \$58,000 to be paid in December prior to shipment, and \$177,000 when the baler and conveyor are shipped. The final \$28,000 is to be paid 30 days after installation and training.

She said all the money will come out of the landfill budget, and the concrete and doors for the new building will come out of capital outlay. The bill has been paid to Schlosser Concrete, she said

Rasure asked how much will be left in the solid waste fund if this is all paid out.

Snethen said there will be \$454,000.

Commissioner Chuck Thomas said he did not see a reason to borrow money for the baler and pay the interest. Rasure asked about the money for the new cell, which will cost \$109,000.

Rumpel said that comes out of the \$200,000 reserve fund the commissioners put aside over the past years for digging new cells. She said it would be good for the commissioners to transfer \$50,000 into the fund this year to get ready for the next cell.

Thomas said the solid waste fund has money com-

"The decisions should be left up to the commissioners."

Rasure said if the proposal is accepted by city, they could have a new agreement drafted. It would eliminate the communications board and leave all the decisions up to the commissioners. They agreed that is the way the dispatch system has been running for the past few years anyway.

County Sheriff Kevin Butts came in to talk about a proposal from S&T

"We need a new program for the civil process function," Butts said. "It has been added into the new system, and we received training on the program.

"The cost of the program is \$3,000. We have a program now, but the information is not going into the main system."

Butts said the server would cost \$6,694, and the new jail computer would be \$1,057.

"I guess it is necessary," Tiede said. "Seems like a lot of money."

"The server is really important," Thomas said, making a motion to purchase the server, computer and software program. It passed unanimously.

#### County Clerk Janet Rumpel said the current agreement says that one side can terminate the agreement if it gives the other notice by July 1, but there is a section which says the agreement can be ended by mutual agreement.
