Sharon Gregory, principal at Central Elementary School, applied for the grant from Prevention of Child Abuse and Neglect. A bullying problem at the high school came up at an educators' retreat, Gregory told the Community Partnership for Prevention and Education at its October meeting.

Partnership members agreed to sponsor the school district as an applicant for the grant, and Roxy Cabral, director of Prevention of Child Abuse and Neglect, announced at the partnership's November meeting Tuesday that the application had been approved.

Increasing electric, water rates to balance budget on city agenda

The Goodland Star-News In order to balance the city budget for next year, the commissioners agreed to raise the electric and water rates.

Following the last regular meeting, the commissioner spent about two hours in a work session discussing how much to raise the electric and water rates to bring them up to balance the budget.

Ordinances for both rate increases will be on the agenda for Monday's meeting.

The commissioners had a consensus at the work session to raise the electric rates by 2 cents per kilowatt-hour. For the average home using 638-kilowatt hours, it will be an increase of \$2 per month.

The other change will raise the base rate from \$28 up to \$70 that the city is covering with the rates. City Manager Wayne Hill said the raise in the base should reduce the amount of fuel adjustment the cus-

"Two cents is a small increase," said Mayor Rick Billinger.

City Clerk Mary Volk said the fuel adjustment was begun in July 2001, and there has only been one month since where there was not a go with the staff recommendation, fuel adjustment cost on the monthly bills.
