Sherman County Historical Society December 15, 1905: Twin Cottages – J.N. Lockwood, carpenter and builder, is erecting twin cottages on south Clark Ave. for C.D. Harper and D.E. Bartholomew. Both cottages are alike as to their exterior, but the interior arrangements are exactly reversed.

They are of the style known as the "French Cottage" and are unique in style and finish. Each have six rooms, a bath room and two closets besides a convenient catchall. They are very roomy, having pleasant overhang porches and bay windows.

December 16, 1905: A New Elevator Assured — In four weeks from now another elevator will be towering into the air along the Rock Island side tracks in Goodland. R.M. Fox of Smoky township will be the proprietor, and the new concern will be known as "The Farmers Elevator."

December 17, 1905: Arm Shattered By Gun – Dr. Carmichael was called to Brewster to perform a surgical operation on Mrs. Hazen. About seven o'clock a.m. Tuesday, while at her housework, a loaded shot gun was dislodged from its place on the wall, and falling exploded, it wounded her in the right thigh and right arm.

Dr. Chester of Brewster telegraphed Dr. Eddy of Colby and Dr. Carmichael of Goodland. The right arm was so badly shattered that it had to be amputated near the shoulder

Dr. Eddy administered the anesthetics and Dr. Carmichael amputated the limb. The woman suffered a severe loss of blood, which complicated the surgical problem. The arm was shattered to a pulp.
