# Beware of bogus e-mails

Dear Attorney General Kline: Irecently received an e-mail, supposedly from the "Security Team" with PayPal, an on-line payment service for eBay, asking that I send my credit card and bank account information. The message appeared to be authentic but I decided not to respond. Is this a scam?

Dear Kansas Consumer:

Schemes designed to persuade consumers to divulge their personal banking and credit card information take many forms, and you are to be commended for recognizing one of them.

Scams involving bogus e-mails posing as legitimate messages from such well-known on-line sites like eBay and PayPal continue to circulate, and many like the one you refer to are particularly convincing. Many times these messages even contain logos identical to the real ones and even a disclaimer in "fine print."

In some of these fake e-mails. consumers are informed that their accounts have been selected at random for maintenance and placed on a "limited access" status and instructs the account holder to send personal bank or credit card information.

Other e-mails ask for private information due to a problem with the



"temporarily unavailable."

Many times these fraudulent emails will request information in- in to its secure server before giving cluding your full name, account password, credit card and bank account numbers, Social Security Number or your mother's maiden name. Again, it is vital to be extremely careful and protective of this information.

While these e-mails appear to be legitimate, don't be tricked into providing information that would permit your identity to be stolen. Here are some clues to use to help determine whether e-mail you receive is from a legitimate source:

 Subject Line: Scammers send out bulk e-mails to random consumers hoping to snare people in their trap. Legitimate agency e-mails will address you by your first and last name or the business name associated with your account, not a *plaint, write Attorney General Phill* generic greeting such as "Dear Member.'

gram from an e-mail without contacting you first.

• Request for Personal Information: Legitimate companies will never request that you send your private and personal bank and

credit card information via e-mail. Instead, they will require you to log access to your account.

Would-be scam artists continue to come up with new and creative ways to try and separate you from your hard-earned money. But no matter how creative these tactics are, by carefully guarding your personal and financial information, you can avoid mistakenly forwarding that information to an identity thief
