## Girl Scouts celebrate organization's history

Girl Scouts of Sunflower Council will celebrate the history of Girl Scouting this week.

Sunday was the 94th anniversary of Girl Scouts of the United States and Girl Scout Sunday, said Monica Legleiter, membership specialist for the council. Many troops across the area planned to celebrate by attending church, she said, hosting overnight events and participating in Scout ceremonies.

The annual Girl Scout Week commemorates the 1912 founding of Girl Scouting in the United States by Juliette Gordon Low. In the 94 years since, the organization has helped shaped the lives of more than 50 million women.

In Girl Scouts, girls from ages 5 through 17 enjoy activities designed to enhance their courage, confidence and character, Legleiter said. Girl Scouting cultivates values, social conscience and self-esteem, she said, while teaching girls skills critical to succeed as adults.

Membership is growing as more and more girls take advantage of the organization's special all-girl environment, Legleiter said. Today, Girl Scouts of Sunflower Council serves more than 850 girls and 330 adults in 16 counties of northwest Kansas, she said, and is a United Way Agency.

"During Girl Scout Week," said Linda Mills, chief executive officer of the council, "we renew our commitment to making sure every girl in northwest Kansas has the opportunity to grow strong and realize their own potential. But we need your help. We invite everyone over 18 in the ... jurisdiction to volunteer with a local Girl Scout troop or council program. You don't have to be a troop leader; even if you can only donate one hour of your time once a year, you'll be making a great difference in the lives of Northwest Kansas girls."
