The Goodland Star-News Sherman County commissioners heard Tuesday that Cheyenne County has passed a resolution to join Sherman and Wallace counties in the Sunflower Extension District this July.

Dana Belshe, extension agent for Sherman County, and members of the district board came to talk to the commissioners.

Schilling said the district is doing well, and they are working on joint events between the two counties. The district was formed last year and began operating in July.

Jeanne Falk, the agronomist for all three counties, is based in Colby. She said they have done a couple of joint projects over the past few months, including a weed identification program that brought out about 20 farmers.

"The attendance was great," Falk said, "and the farmers were pleased with the amount of individual attention they received on how to identify and spray weeds."

Visitor board buys new van

tion and Visitors Bureau board chose a new work van for the bureau director and got a discount on an ad in a publication that reaches nearly half a million homes at a special meeting.

The board had requested bids from Goodland car dealers and had two vans to choose from at Herl Chevrolet, a van and a sport utility Albers, who received his promo- vehicle from Finley Motors and

brochures to hand out at the trade shows.

Other choices ranged from \$13,600 for a 2005 Free Star with 19,800 miles to \$20,825 for a 2006 Ford Free Style with zero miles.

The board rejected a Trail Blazer from Finley because of gas mileage, and several members said they felt the decision should be at least partly based on how well the vehicles met the specifications they requested from the dealers.

The other vehicle from Finley's was a 2006 Montana van with zero miles for \$18,313. The vehicles from Herl's were a 2005 Town and Country with 21,000 miles and a 2005 UpLander with 16,000 miles. Each were around \$16,500 with \$2,000 allowed for the trade in. The bids included a reduced price for the county.
