'Betrayed by a Fingerprint' — A definite Must Read

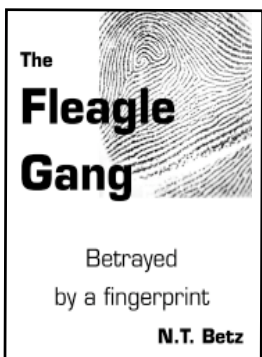
