'Work at home, stuffing envelopes' ads don't tell the whole story

Dear Attorney General Kline: I've been looking for ways to increase my income but don't have the time for a second job. I noticed a newspaper ad that offered the chance for me to work from my home at my own pace by stuffing envelopes for an out-of-state company. It seems like it would fit my situation well, but I guess I'm a little skeptical.

Dear Kansas Consumer:

While there are many reputable companies that offer legitimate business opportunities, you are definitely wise to be skeptical.

Advertisements for businesses like the one you mention make similar claims and offers:

While these ads seem appealing, they don't reveal the entire story These envelope-stuffing "oppor- because these promoters are not re-

instructing them to place the same "envelope stuffing" ad in magazines or newspapers, or even to forward the ad on to relatives and friends. So the only way money is earned by consumers is if people answer their ad.

If you are tempted by one or more of these "envelope stuffing" ads, you should get satisfactory answers to these questions before signing up to get more information or sending any money: When will I get my first pay-

check and who will pay me? Will my pay be on a commission

basis or will I be paid a set salary? · Exactly what will I be expected to do to earn my paycheck?

 What is the total cost of the envelope stuffing program, including

all supplies, equipment, and any membership fees?

• What will I get for my money? The answers to these questions should help consumers decide complaints, change their names or whether a particular opportunity is legitimate and whether it is appropriate for their circumstances.

It's also a good idea to do some research on any company with which you are considering a business relationship. I encourage you to check with my Consumer Protection Division and the Better Business Bureau both where the company is located in addition to the community where you live.
