'Chalk rock' find made news

In 1931, *The Goodland News-Republic* reported the discovery of a large lime deposit on the Marshall Ranch (later known as the Cogswell and T-Bar Ranch) in southeast Sherman County and northern Wallace County. However, it would be several years before the "chalk rock" would be retrieved and processed.

Curtis McKenrick, who lives across the street from the now abandoned plant in Edson, said that the diatomaceous material comprises fossils of microscopic sea algae that contain silica.

The pulverized rock was bagged and shipped by rail by the American Lead Co., which used it in leadbased paint. It was also used as a ballast in tractor tires. McKenrick noted too area baseball teams liked to use the "chalk" material to mark the field lines and put it on sweaty hands because it was not caustic.

FIND LIME NEAR HERE Believe Million Tons in

Marshall Ranch Deposit

Raw materials that appear to be suitable for the manufacture of hydraulic lime have recently been found in Wallace County, according to circular No.3 issued recently by the State Geological Survey. Since the United States now imports this substance from Europe, the find may prove to have considerable commercial importance.

The deposit found upon the Marshall Ranch is known as diatomaceous marl, called "chalk rock," and amounts to one million tons according to estimates. Hydraulic lime is used for constructing tunnels under rivers, as it hardens and "sets" under water.

It is also valuable for foundations and basements where setting may occur, as it is slow in setting, and the structure built of it takes its permanent position before the lime sets, and thus cracks are avoided.
