Eugene A. Blake, 75, Goodland, died Monday, June 19, 2006, at Goodland Regional Medical Center after a long battle with cancer.

He was born Sept. 1, 1930, at Cando, N.D., the son of Arnold and Erna (Schumacher) Blake. He attended schools in Hampden, N.D.
