# Council searching for people

Terms of Kim Bohme, treasurer, and Don Newell, vice-chairman, are expiring. Bohme said at the annual meeting on Oct. 19, she is not going to seek another three-year term. Newell said he has not made a decision.

Chairman Shelly Thompson asked for nominations from the floor, but there was none. She said the council will accept nominations at the office at 104 E. 10th until Friday, Nov. 17. She said the nominees will be asked to come to the council meeting at 5:30 p.m. on Tuesday, Nov. 21, when the election will be held.

Thompson said the term of Dwane Timm, member from the First National Bank, is expiring, but that position is nominated by the bank.

Development Director Tiffani McMinn asked why there was no representative from People's State Bank

Thompson said there has not been a representative from the bank since Randy Schoenthaler left over a year ago. Thompson said it is up to the bank to nominate a person for the position.

one to replace them.

"We need industry," he said, "but we need to take care of the business that is already here."

The county needs to provide the things that retirees need so they don't move away, he said. Regulations shouldn't antagonize groups the town wants to attract and keep. He said he figured about 55 percent of Goodland's population is retired. "I think that there should be an

exemption to the two-hour parking for motor homes that are from out of town," he said.

He said he's concerned that laws and regulations should not force people to leave their homes to go to retirement communities or housing. Pettijohn said he thinks the county and city should cooperate on anything they can. Each item should be looked at, he said, and some common sense used. He did not want to speculate on what, saying that as a commissioner he would have more

Chuck Thomas is the incumbent commissioner who is facing challenges from Darin Neufeld and Conrad Pettijohn. Thomas won the four-way Repubican Primary Election in August defeating Neufeld by 14 votes.

Neufeld decided to run as a write-in candidate because the vote was so close, and he felt it would have beennn different if there had not been four candidates to split the votes.

insight as to what the two could do together.

District 3, is in a three-way race to hold on to his job, facing Conrad Pettijohn, an independent whose name is on the ballot, and Darin Neufeld, an engineer whom he beat

when it comes budget time.

"I have a great working relationship with the department heads," Thomas said. "I understand their needs, and we work together.

"I don't let outside influences make my decisions. I try to use a business-like approach to my decisions like I do for my own farm. I try to get the taxpayers the best value for their money."

A key part of solving the money issue is drawing different businesses and people to the area, he said, especially with farming taking such a hard hit from the weather. In an agriculture-based economy, he said, when farmers have more income, they spend more downtown. The weather turning around will be a big help, he said, but the county needs money from other sources as well.

Hopefully, things will continue to grow with economic development in the county, he said, adding that the Goodland Energy Center will likely be a big help.

Also, he said, a company from Dallas, Rosewood Resources, is looking for natural gas in the county. They are drilling a lot of wells, which will put money back into the county when they are up and running, Thomas said. Right now, they have a crew of at least 10 staying in motels, eating and shopping here

The candidate said Sunday he has been canvassing the district house to house, with just a few blocks near the Northwest Kansas Technical College and the Armstrong and Paxton additions to finish this week.

"I am hearing a lot of positive stuff," he said. "This last week, we did about a third of the city part of the district, and Saturday a lot of people told me and the people helping that they had already voted. Alot said they had voted for me already.

"It worries me about the type of turnout we are going to have. I am glad people are voting early, but it makes we wonder what the turnout will be on Election Day on Tuesday.'

Ireasurer wants to keep driver's license renewals

The Goodland Star-News A new federal law will require everyone to have an approved "national" ID to get on an airplane or enter a federal building, and that might stop Kansas county treasurers from renewing drivers's licenses.

If that happens, people would have to drive 30 to 100 miles to a state-run license office, rather than make a quick trip to the courthouse as they do today.

Sherman County Treasurer Iris Scheopner said she is backing a petition to let Congressman Jerry Moran know that the people of rural Kansas do not want to lose the ability to come to her office to renew their driver's licenses.

was passed by Congress in May 2005 as a rider on a defense department funding bill to pay for the war in Iraq and for tsunami relief. The law requires states to adopt a new federal driver's license format by 2008. She said the problem with the plan was discussed at a recent meeting of the Kansas County Treasurer's Association with state Secretary of Revenue Joan Wagnon.

Scheopner said the law would require everyone to get a new driver's license. Wagnon said the requirements might eliminate the county treasurers from being able to do any renewals. Scheopner said she wrote to Congressman Moran about the Real ID program to say that this would threaten

Scheopner said the new federal law – known as Real ID the quality of life in rural Kansas, and that 82 county treasurers in Kansas who do license renewals wanted to make sure they can provide this service to their residents.

Moran responded by writing to Secretary of Homeland Security Michael Chertoff asking that the Real ID regulations "recognize the authority of county treasurers to continue to renew driver's licenses."

"Kansans should not have to travel long distances to renew their driver's licenses," Moran said.

Scheopner said she feels eliminating the county offices would be a hardship to senior citizens, disabled drivers and
