

Notice of Sale

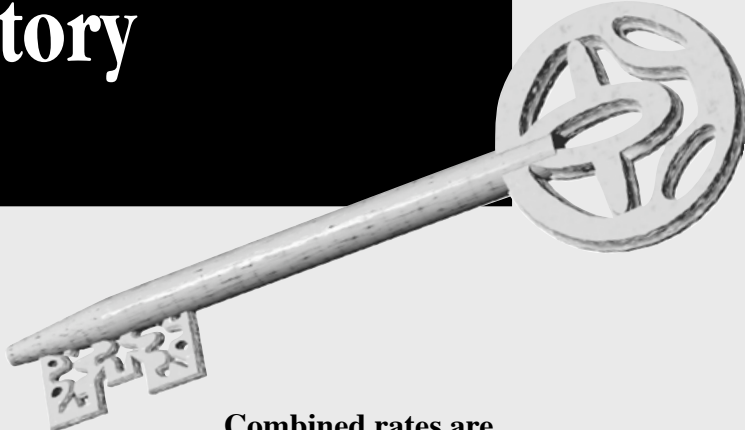
