Couple married Christmas Day 1941

The Goodland Star-News Their best defense seems to be "Pearl Harbor made us do it," but Frank and Norma (Kail) Schlepp don't regret for a minute they married on Christmas Day 65 years ago.

He was born in a sod house in Cheyenne County 12 miles south of St. Francis, and she grew up on a farm 12 miles north of Ruleton. They went to the same country church, a few miles from their families' farms.

"I don't even know when and how we met," Mrs. Schlepp said. We just went to church there."

The church had a youth group that met on Sunday evenings, she said, and everyone in the neighbor- she said. "Many came back and hood had parties where people got started their lives here and put it together and played games out in behind them."

New Guinea was jungle, he said, with just a few natives living there, no villages or anything. He was in combat 318 days there without a break, then he went to the Philippines on New Year's Day 1945 for more combat.

In October, he said, they loaded everything on a ship and were ready to go to Japan, but the bombs were dropped on Hiroshima and Nagasaki, so they came home.

"It was nothing unusual that I did," he said. "I was just part of a team. Some had it a lot worse than I did; I lost men."

the yard. It was too far to go to town then, she said; the kids didn't have farm north of Ruleton, a mile and a cars, nor money for gas.

Mr. Schlepp was drafted in May of 1941, thinking he was going to serve in the Army a year. In December, Pearl Harbor was bombed, he said, and all furloughs were canceled.

He was stationed at Fort Leonard Wood but was able to get a threeday pass to come home on leave for Christmas, so the two married Dec. 25, 1941, at the Neville parsonage in St. Francis. There was a blizzard, he said, adding that he got stuck going to his parents' place. The older ones probably wondered what these silly kids were doing, she said.

"We never wish we wouldn't have," she said.

"We've had a good life together," he said. "It was hard work sometimes, but we made it. We did what we had to do."

"We raised three children," she said. And they have their college education, he added.

He was 23 when they married, and she was 21. Before they married, she had taught two years at a country school in Sherman County then one year at the country school Retirement Community. she attended.

Their first four years of marriage, he was in the Army, stationed in Hawaii, then New Guinea a year, then the Philippines. He was a combat engineer. She went with him

When he returned, they bought a half from where she grew up. They had four children; the first, Barbara, died as a two-day old infant, then in 1949, they had a daughter, Joann. She and her husband Gary Ross live in Haviland, where she works at the post office, and he is a farmer.

The Schlepps had twins in 1953, Dennis, who died in 1988, and Darlene who lives in Boise, Idaho, with her husband Dan Sutton. She is a homemaker and works part time in a Williams-Sonoma store, and he is a produce buyer for Albertson's.
