She was preceded in death by her husband, Lloyd, on May 28, 2000; sisters, Nettie Skubal, Ruth (Tacha) Wade, and Sylvia Peters, and brothers, Herbert, Stanley, Julius, Harry, Frank, Rudolph and Alfred Petracek.
