When the group found only one person interested in being a quarter chairperson—Karen Metcalf of the Dresser, outgoing president of the group—Julie Kennedy of KSNK television asked what the organization did to recruit members. Mrs. Metcalf said that in the past they haven't really done anything.

Mrs. Wasson said she thought the group should be trying to get new members all the time. Mrs. Metcalf said that she did put an ad in the paper to thank people who were members and have helped in the past, hoping that maybe it would spark some interest, but it hasn't. She also suggested putting a small laminated sign in business windows of people who are members.

Mr. Stanley said that a lot of those who are not members are not on Main Street and think the promotions are mostly for those businesses. Although the alliance has tried to make businesses on the highway and in other areas of town a part of what they do, some
