You, and each of you, are hereby notified that Landmark Resources, Inc. has filed an application to amend the pressure of the injection of salt water into the Arbuckle and Granite Wash formations at the Adell Unit #1 Bouts, located in the SW NW NE of Section 2-T6S-R27W, Sheridan County, Kansas. Injection rate will be a maximum of 4,000 barrels of water per day at a maximum of 1000 psi.

Any persons who object or protest this application shall be required to file their objections or protests with the Conservation Division of the State Corporation Commission of the State of Kansas within fifteen (15) days from the date of publication.

These protests shall be filed pursuant to Commission regulations and must state specific reasons why the grant of the application may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas. If no protests are received, this application may be granted through a summary proceeding. If failed protests are received, this matter will be set for hearing.

ORDINANCE NO. 414

AN ORDINANCE RELATIVE TO CHARGES FOR WATER AND SEWER PURCHASED FROM THE CITY OF JENNINGS, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF JENNINGS, KANSAS:

Section 1. The minimum charge for water purchased from the City of Jennings shall be Five Dollars (\$5.00) for each month. The customer shall be entitled to Four Thousand (4000) gallons or any fraction thereof. All gallons over the minimum 4000 gallons shall be charged at a rate of Two Dollars (\$2.00) per each Thousand (1000) gallons.

Section 2. Customer meters shall be read each month.

Section 3. The charge for sewer service shall be Four Dollars (\$4.00) for each month that the water service is turned on. Water customers that are not connected to the City sewer lines are not charged for sewer service.

Section 4. Policies, for example due dates, shall be made by motion of the City Council and may be changed from time to time. Customers shall be given notice of these changes.

Section 5. This ordinance shall take effect from and after July 1, 2003.

Section 6. All ordinances or parts of ordinances in conflict herewith are repealed.
